4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre. (Phone Australia 131 126; New Zealand 03 474 7000).

Ingestion: Rinse mouth with water. Give water to drink. Do NOT induce vomiting. Seek immediate medical assistance.

Eye contact: Continue to Irrigate with copious quantities of water until medical help is available. Eyelids to be held open. Remove clothing if contaminated and wash skin. Urgently seek medical assistance. Transport to hospital or medical centre.

Skin contact: Wash contaminated skin with plenty of water. Remove contaminated clothing and wash before reuse. If irritation occurs seek medical advice.

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

5. FIRE-FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Wear protective equipment to prevent skin and eye contamination and inhalation of dust. Sweep up, but avoid generating dust. Collect and seal in properly labelled containers for disposal. Wash area down with excess water.

7. HANDLING AND STORAGE

Handling: Avoid skin and eye contact. Wear protective equipment to prevent skin and eye contact and inhalation of dusts.

Storage: Keep dry. Keep containers closed at all times. Avoid any dust build up

8. EXPOSURE CONTROLS / PERSONAL PROTECTION

TWA – the Time-Weighted Average airborne concentrations over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) – the average airborne concentration over a 15-minute period which should not be exceeded at any time during a normal eight-hour work day. According to current knowledge these concentrations should neither impair the health of, nor cause undue discomfort to, nearly all workers.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. Exposure Standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

Engineering measures: Ensure ventilation is adequate and that air concentrations of components are controlled below quoted Exposure Standards. Avoid generating and inhaling dusts. Use with local exhaust ventilation or while wearing dust respirator. Keep containers closed when not in use.

Personal protection equipment: OVERALLS, SAFETY SHOES, SAFETY GLASSES, GLOVES(S), DUST MASK.

Avoid skin and eye contact and inhalation of dust. Wear overalls, chemical goggles or safety glasses and impervious rubber gloves. Avoid generating and inhaling dust. If inhalation risk exists, wear dust mask/respirator meeting the requirements of AS/NZS 1715 and AS/NZS 1716. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storing or reusing.

Stability: Stable under normal conditions of use and storage.

11. TOXICOLOGICAL INFORMATION

Acute Effects
